**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR LEGAL SERVICES**

**WHEREAS**, Monmouth County Regional Health Commission #1 has need for professional legal services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and,

**WHEREAS**, the Monmouth County Regional Health Commission # 1 has determined and certified in writing that the anticipated value of the services may exceed \$16,700; and, N.J.S.A. 40A:11-5 does not require bidding for professional legal services; and

**WHEREAS**, this contract is effective January 1, 2019 through December 31, 2019; and,

**WHEREAS**, Mr. Bruce W. Padula, Esq. of Cleary Giacobbe Alfieri & Jacobs, LLC has submitted a proposal indicating they will provide legal services pursuant to the agreement; and

**WHEREAS**, Mr. Bruce W. Padula, Esq. of Cleary Giacobbe Alfieri & Jacobs, LLC has completed and submitted a C.19 Business Entity Disclosure Certification, Stockholder Disclosure Certificate and a C.271 Political Contribution Disclosure Form which certifies that Mr. Bruce W. Padula, Esq. has not made any reportable contributions to a political or candidate committee associated with any of the Municipalities serviced by the Commission in the previous one year, and that the contract will prohibit Mr. Bruce W. Padula, Esq., from making any reportable contributions through the term of the contract, and

**WHEREAS**, funds are available for this purpose for the balance of the 2019 budget under:

**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution, and

**BE IT FURTHER RESOLVED** that notice of this appointment shall be published as may be required by law, and

**BE IT FUTURE RESOLVED** that a copy of this resolution shall be on file in the Monmouth County Regional Health Commission and available for inspection as required by law.
