RESOLUTION 2019- 59**

**RESOLUTION APPROVING THE NAME CHANGE OF THE PUBLIC HEALTH NURSE MANAGER AND TEMPORARY ASSIGNMENT TO THE MPHIC**

**WHEREAS**, MCRHC is in need of a Public Health Nurse Manager, and

**WHEREAS**, the Commission currently has an employee that meets the requirements of this role and is able to satisfy the requirements of the NJDOH Strengthening Local Public Health Capacity Program Grant;

**WHEREAS**, the members of the Monmouth Public Health Consortium (Colts Neck, Manalapan & City of Long Branch) have approved of this temporary addition of a Public Health Nurse Manager to the Consortium for this NJDOH Grant;

**WHEREAS**, the Union has reviewed and approved this name change and temporary assignment to the Consortium;

**WHEREAS**, the members of the Human Resources Committee have been advised of this name change and temporary assignment;

**WHEREAS**, the effective date will be recorded as November 18, 2019 with adequate funds available in the 2019 budget; and;

**WHEREAS**, this name change will have no financial effect on MCRHC/MPHC; and

**WHEREAS**, the name change is necessary due to the increased State statutory requirements and duties for public health nursing

**WHEREAS**, this assignment to the MPHIC is contingent on grant funding that will end at the close of business on June 30, 2020; and

**WHEREAS**, MCRHC is not bound to continue this assignment to the MPHIC if the NJDOH grant is not renewed and adequate fee for service is not provided from the MPHIC; and

**NOW THEREFORE, BE IT RESOLVED** that the Commission hereby authorizes the Health Officer to change the name of Public Health Nurse to Public Health Nurse Manager temporarily assign Ammar Rizvi, BSN to the MPHIC at a stipend of \$8,000 for the length of the grant and;

**BE IT FURTHER RESOLVED** that the Health Officer shall notify the individual of their conditional status and the funding contingency of their continued temporary assignment; and

**BE IT FURTHER RESOLVED** that the President and Health Officer are authorized to sign any documents related to this name change temporary assignment, as appropriate; and

**BE IT FURTHER RESOLVED** that notice of this appointment shall be published as may be required by law.

**BE IT FURTHER RESOLVED** that a copy of this resolution shall remain on file in the Monmouth County Regional Health Commission and available for inspection as required by law and also filed with the following:
