A RESOLUTION OF THE MONMOUTH COUNTY REGIONAL HEALTH COMMISSION NO.1 OF THE AUTHORIZING THE SALE OF SURPLUS PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE ON AN ONLINE AUCTION WEBSITE

WHEREAS, the Monmouth County Regional Health Commission No. 1 (“MCRHC”) has determined that the personal property described on Schedule A attached hereto and incorporated herein is no longer needed for public use; and

WHEREAS, the MCRHC intends to utilize the online auction services of Municibid located at www.municibid.com ; and

WHEREAS, the sale of the surplus property shall be conducted through Municibid pursuant to New Jersey State Contract T2581 – Auctioneering Services; Internet Auctions to Sell Surplus Property – Bid # 19DPP00272;

WHEREAS, the sales are being conducted pursuant to N.J.S.A. 40A:11-36 and the guidance set forth in the Division of Local Government Services’ Local Finance Notice 2019-15.

NOW, THEREFORE, BE IT RESOLVED by the MCRHC in the County of Monmouth, State of New Jersey, that the MCRHC is hereby authorized to sell the surplus personal property as indicated on Schedule A on an online auction website entitled www.municibid.com ; and

BE IT FURTHER RESOLVED, that the terms and conditions of the agreement entered into between Municibid and the MCRHC are available at ; www.municibid.com and at the MCRHC office; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be on file in the Monmouth County Regional Health Commission and available for inspection as required by law.
