RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR LEGAL SERVICES

WHEREAS, Jersey Shore Regional Health Commission has need for professional Conflict Counsel legal services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and,

WHEREAS, the Jersey Shore Regional Health Commission has determined and certified in writing that the anticipated value of the services may exceed \$9,600; and, N.J.S.A. 40A:11-5 does not require bidding for professional legal services; and

WHEREAS, this contract is effective January 1, 2024 through December 31, 2024; and,

WHEREAS, King, Kitrick, Jackson & McWeeney, LLC has submitted a proposal indicating they will provide legal services pursuant to the agreement; and

WHEREAS, Mark G. Kitrick Esq. of King, Kitrick, Jackson & McWeeney, LLC has completed and submitted a C.19 Business Entity Disclosure Certification, Stockholder Disclosure Certificate and a C.271 Political Contribution Disclosure Form which certifies that Mr. Mark G. Kitrick, Esq. has not made any reportable contributions to a political or candidate committee associated with any of the Municipalities serviced by the Commission in the previous one year, and that the contract will prohibit Mr. Mark G. Kitrick, Esq., from making any reportable contributions through the term of the contract, and

WHEREAS, funds are available for this purpose for the balance of the 2024 budget under:

NOW THEREFORE, BE IT RESOLVED by the Jersey Shore Regional Health Commission that the aforesaid preamble be and is hereby incorporated into this Resolution; and

BE IT FURTHER RESOLVED that the Jersey Shore Regional Health Commission authorizes its Health Officer or Chairperson to enter into a contract with Mark G. Kitrick, Esq. of King, Kitrick, Jackson & McWeeney, LLC as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution, and

BE IT FURTHER RESOLVED that notice of this appointment shall be published as may be required by law, and

BE IT FURTHER RESOLVED that a copy of this resolution shall be on file in the Jersey Shore Regional Health Commission and available for inspection as required by law.
