# ORDINANCE NO. 2024-2 AN ORDINANCE AMENDING CHAPTER 7 OF THE ADMINISTRATIVE CODE OF THE JERSEY SHORE REGIONAL HEALTH COMMISSION

WHEREAS, the Commission has established an Administrative Code of the Jersey Shore Regional Health Commission; and

WHEREAS, Chapter 7 of the Administrative Code is titled Non-Food Inspection Services; and

WHEREAS, the Commission finds that it is in the best interest of the public health and its contract municipalities that Chapter 7 of the Code be amended.

NOW, THEREFORE, BE IT ORDAINED by the JERSEY SHORE REGIONAL HEALTH COMMISSION, created and operating pursuant to N.J.S.A. 26:3-83 et seq., as follows:

<u>Section 1.</u> Chapter 7 "Non-Retail Food Establishment Inspection Services" of the Administrative Code of the JERSEY SHORE REGIONAL HEALTH COMMISSION (JSRHC) shall be amended as follows (<u>underlines</u> represent additions, <u>strikethroughs</u> represent deletions):

#### **CHAPTER 7**

Non-Retail Food Establishment Inspection Services

## 7-1 Establishment of Fixing Fees for Non- Retail Food Establishment Inspection Services

**Editor's note:** Prior ordinances codified herein include versions of Ordinance No. 6, original version published December 2008, beginning 08-06 adopted and edited through 18-06.

#### 7-1.1 **Definitions**

- a. *Sewerage Disposal System*. The term "Sewerage Disposal System" shall mean any method or system of removing or disposing of sanitary sewerage.
- b. *Body Art*. The term "Body Art" shall mean the practice of physical body adornment that is permitted in establishments operated by licensed operators utilizing, but not limited to, the following techniques: body piercing; tattooing; and permanent cosmetics.
- c. Public Swimming Pools/Private Recreational Bathing Facilities. The term "Public





Swimming Pools/Private Recreational Bathing Facilities" shall mean a public/private watertight structure of concrete, masonry, or other approved materials, located either indoors or outdoors, used for bathing, wading, or swimming and filled with a filtered and disinfected water supply, together with buildings, appurtenances, and equipment used in connection therewith.

- d. *Kennel*. The term "Kennel" shall mean any establishment wherein or whereon the business of boarding or selling dogs or breeding dogs for sale is carried on, except a pet shop.
- e. *Pet Shop*. The term "Pet Shop" shall mean Any place of business which is not part of a kennel, wherein animals, including, but not limited to, dogs, cats, birds, fish, reptiles, rabbits, hamsters or gerbils, are kept or displayed chiefly for the purpose of sale to individuals for personal appreciation and companionship rather than for business or research purposes
- f. *Pound*. The term "Pound" shall mean any establishment of the confinement of dogs or other animals seized either under the provisions of N.J.S.A. 4: 19-15.16 or otherwise.
- g. *Shelter*. The term "Shelter" shall mean any establishment where dogs or other animals are received, housed and distributed.
- h. *Private Well*. The term "Private Well" shall mean a potable water well that serves a dwelling unit and is located on the same real property as the dwelling unit.
- i. *Private Irrigation Well*. The term "Private Irrigation Well" shall mean a well permitted as such and utilized for the application of water to the land or soil, to assist in the growing of agricultural crops, maintenance of landscapes, and re-vegetation.
- j. *Daycare Center, Preschool or School.* The term "Daycare Center, Preschool or School" shall mean full- or part-time care in a residential or nonresidential setting for six or more children under 13 years old for fewer than 24 hours per day. In New Jersey, this includes nursery schools, preschools, pre-kindergartens, and religiously affiliated centers.
- k. *NJ Smoke-Free Air Act*. The term "NJ Smoke-Free Air Act" shall mean the NJ SFAA which prohibits smoking in essentially all workplaces and places open to the public, effective April 15, 2006.
- 1. Vaccine Administration. The term "Vaccine Administration" shall mean the route of delivery by which a vaccine (or drug) is brought into contact with the body. This is a critical factor for success of the immunization.

#### **7-2 Fees**

The Commission hereby establishes and fixes the following fees for non-food health services:

## 7-2.1 Sewerage Disposal System

#### 7-3 Collection of Fees

All fees covered pursuant to Section 7.1 et. seq. of this, Ordinance, with the exception of Section 7-2.2a and 7-2.3e-i, and 7-2.4b Annual Health Licensing Permit Fees, shall be paid directly to the Regional Health Commission within that health agency's geographic jurisdiction where such fees are assessed and collected.

The fee covered pursuant to Section 7-2.2a and 7-2.3e-i, and 7-2.4b Annual Health Licensing Permit Fee shall be paid directly to the town Municipality of geographic jurisdiction wherein the establishment is regulated by the Body Art Code is located.

- Section 2. The remainder of Chapter 7 "Non- Retail Food Establishment Inspection Services" of the Administrative Code of the JERSEY SHORE REGIONAL HEALTH COMMISSION shall remain unchanged.
- Section 3. The Health Officer and Commission Secretary are hereby authorized and directed to take any ministerial action consistent with the intent of this Ordinance.
- <u>Section 4.</u> REPEALER. All prior Ordinances or parts of same consistent and/or inconsistent with any of this Ordinance established hereunder are hereby repealed.
- SEVERABILITY. In the event that a court of competent jurisdiction shall declare any section, sentence or clause of this Ordinance unconstitutional, such declaration shall not in any manner prejudice the enforcement of the remaining provisions.
- <u>Section 6.</u> EFFECTIVE. This Ordinance shall take effect upon passage and publication in accordance with applicable law.
