RESOLUTION 2026 - 39

A RESOLUTION AUTHORIZING THE PUBLICATION OF LEGAL NOTICES ON THE JERSEY SHORE REGIONAL HEALTH COMMISSION OFFICIAL WEBSITE WWW.JSRHC.ORG

WHEREAS, New Jersey's historical requirement for local governments such as Regional Health commissions to publish public notices in newspapers through regulations such as Title 35 (Legal Advisements) of the New Jersey Revised Statutes, the Open Public Meetings Act (OPMA), and individual acts like the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)

WHEREAS, these long-standing print mandates were fundamentally updated and replaced by P.L. 2025, c 72 (S-4654), which shifted legal requirements of providing public notice by having local government entities to now publish public notices directly on their official government websites in a free-to-access area, and archiving them for at least one year as signed by Governor Phil Murphy on June 30, 2025, and scheduled to come into effect starting March 1, 2026; and

WHEREAS, the Jersey Shore Regional Health Commission's (JSRHC) Chief Financial Officer, Commission Treasurer, Business and Finance Chair, and Health Officer review the JSRHC bills on a monthly basis; identify significant cost in utilizing newspapers to publish public notices; and

WHEREAS, the governing body of the JSRHC recognizes the importance of ensuring timely, accessible, and transparent communication with the public; and

WHEREAS, the publication of legal notices through its official municipal website, www.JSRHC.org, will enhance public access, reduce costs, and improve efficiency in meeting statutory notice requirements;

NOW THEREFORE BE IT RESOLVED that the JSRHC approves and hereby authorizes the publishing of all eligible legal notices of the official JSRHC website, www.JSRHC.org, in accordance with the applicable laws and regulations. The Health Officer and Office Coordinator will ensure that such notices are posted in a timely manner and remain accessible for the legally required duration.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be on file at the Jersey Shore Regional Health Commission and available for inspection as required by law.
