A RESOLUTION FOR ENTERING INTO AN AGREEMENT WITH THE CLEAN MANAGEMENT ENVIRONMENTAL GROUP, INC WITH OFFICES AT 915 INDUSTRIAL RD, WALTERBORO, SC 29488, FOR THE PURPOSE OF HAVING TWO XRF ANALYZER GUNS DECOMMISSIONED AND SAFELY DISPOSED OF

WHEREAS, it has been determined that Jersey Shore Regional Health Commission's (JSRHC) Niton XRF Analyzer XLP 300 with a Cadmium-109 sealed battery source, and LPA-1, XRF Gun with Cobalt- 57 sealed battery source are no longer needed to provide public health services; and

WHEREAS, these items contain hazardous materials, including but not limited to sealed radioactive sources, which require specialized handling; and

WHEREAS, JSRHC is committed to ensuring that all hazardous equipment is disposed of in compliance with applicable federal, state, and local environmental regulations, including those of the U.S. Environmental Protection Agency (EPA) and the Occupational Safety and Health Administration (OSHA); and

WHEREAS, the safe disposal of such equipment is necessary to protect the health and safety of personnel, the public, and the environment;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the JSRHC in the County of Monmouth, State of New Jersey, to enter into an agreement with CLEAN MANAGEMENT ENVIRONMENTAL GROUP, INC 915 Industrial Rd, Walterboro, SC 29488 for the safe, lawful, and environmentally responsible disposal of these Lead analyzers for **the total amount of \$2,295.00**; and

BE IT FURTHER RESOLVED, that the terms and conditions of the agreement entered into between CLEAN MANAGEMENT ENVIRONMENTAL GROUP, INC and the JSRHC are available at www.cleanmanagement.com and the JSRHC office; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be on file at the Jersey Shore Regional Health Commission and available for inspection as required by law.
